Assalamualaikum Warahmatullahi Taala Wabarakatuh dan Salam Sejahtera,

Bersyukur kita ke hadrat Allah S.W.T. kerana dengan limpah kurniaNYA, maka kita berpeluang untuk sama-sama berhimpun sempena Mesyuarat Agung Tahunan Yayasan Pencegahan Jenayah Malaysia Kali Ke-29 dan Ke-30.

Saya ingin mengambil kesempatan ini untuk merakamkan ucapan tahniah dan terima kasih kepada MCPF di semua peringkat yang telah berjaya mengaturkan pelbagai program serta inisiatif pencegahan jenayah selari dengan objektif penubuhan MCPF.

Seperti yang kita semua sedia maklum, hasil kerja keras Polis Diraja Malaysia (PDRM) dengan dibantu oleh agensi-agensinya yang lain, kadar indeks jenayah telah berjaya diturunkan sejak beberapa tahun kebelakangan ini. Pelbagai inisiatif telah diambil oleh pihak PDRM bagi memastikan keselamatan orang awam dan komuniti sentiasa terpelihara. Syabas dan tahniah saya ucapkan kepada Polis Diraja Malaysia.

Walau bagaimanapun, tidak dinafikan pihak kerajaan perlu memikul tanggungjawab utama, tetapi penyertaan aktif masyarakat dan segmen lain dalam komuniti amat penting bagi mengawal peningkatan kadar jenayah. Kita tidak boleh leka dan pandang remeh isu berkaitan keselamatan dan kesejahteraan awam.

Seiring dengan kemajuan teknologi, *trend* jenayah masa kini telah pun berubah ke arah teknologi digital dan yang sedang hangat diperkatakan kini ialah jenayah siber. Saya memandang serius jenayah siber yang semakin mengancam keselamatan negara. Jenayah ini semakin meningkat sejak negara dilanda pandemik COVID-19. Ramai di kalangan orang awam menjadi mangsa dan kehilangan jutaan ringgit saban tahun akibat pelbagai kes penipuan di atas talian ataupun *online scam* ini.

Menyedari peningkatan kes jenayah siber ini, MCPF di semua peringkat perlu mempergiatkan usaha dalam memberi pendedahan kepada masyarakat agar tidak terpedaya dengan helah sindiket penipuan ini. Kerjasama rapat dengan agensi-agensinya yang terutama PDRM bagi membendung isu ini daripada terus merebak perlu dipertingkatkan lagi.

Saya berharap MCPF di semua peringkat akan terus bergiat lebih proaktif dengan melaksanakan pelbagai program dan aktiviti pencegahan jenayah bagi memastikan kadar jenayah negara terus menurun dan masyarakat hidup dalam keadaan harmoni sejajar dengan konsep Malaysia Madani.

1. PENDAHULUAN

- 1.1 Mesyuarat Agung Tahunan MCPF Kali Ke-28 dimulakan dengan ucapan Pengacara Majlis dan nyanyian lagu Negaraku. Seterusnya bacaan doa oleh Ustaz Haji Ruzaidi bin Abd. Rashid dari Bahagian Agama dan Kaunseling (BAKA), Jabatan Integriti dan Pematuhan Standard Ibupejabat Polis Diraja Malaysia (PDRM) Bukit Aman.

2. UCAPAN ALUAN YAB Pengerusi MCPF

- 2.1 YB Dato' Seri Hamzah bin Zainudin mengucapkan ribuan terima kasih kepada semua yang hadir pada Mesyuarat Agung Tahunan Kali Ke-28 pada hari ini.

Makluman

- 2.2 Beliau memaklumkan ini merupakan kali pertama beliau mempengerusikan Mesyuarat Agung Tahunan MCPF, setelah mempengerusikan Mesyuarat EXCO MCPF Bilangan 2-2020/2022 bersama-sama dengan semua ahli EXCO yang dilantik dan yang dipilih.

Makluman

- 2.3 YAB Pengerusi merakamkan ucapan penghargaan kepada YAB Perdana Menteri, Dato' Seri Ismail bin Sabri selaku Penaung MCPF kerana memberi kepercayaan kepada beliau untuk menerajui Yayasan ini.

Makluman

- 2.4 YB Pengerusi memaklumkan bahawa Mesyuarat Agung Tahunan (AGM) ini sepatutnya diadakan pada bulan Mac 2021 namun terpaksa ditunda kerana pandemik Covid-19. AGM yang diadakan hari ini adalah untuk tahun 2020 manakala AGM bagi tahun 2021 dijadualkan pada akhir tahun 2022.

Makluman

- 2.5 YB Pengerusi memaklumkan bahawa beliau sedar MCPF di semua peringkat tidak dapat berfungsi dengan baik kerana tiada pelantikan Pengerusi-Pengerusi Jawatankuasa Tetap dan Jawatankuasa Perhubungan Negeri. Namun, pelantikan tersebut telah disempurnakan pada Mesyuarat Exco yang telah diadakan pada 14 Februari 2022 yang lepas.

Makluman

- 2.6 YB Pengerusi memaklumkan bahawa sebagai sebuah badan bukan kerajaan (NGO) yang ditubuhkan sejak 11 Januari 1993, MCPF telah banyak memainkan peranan penting di dalam membantu pihak berkuasa dalam mewujudkan kesedaran kepada masyarakat tentang betapa pentingnya pencegahan jenayah di negara ini.

Makluman

- 2.7 Jelas YB Pengerusi, ini selari dengan objektif penubuhan MCPF iaitu untuk menyumbang kepada peningkatan langkah-langkah berkesan bagi mencegah jenayah dan pemulihan pesalah melalui program-program kerjasama menuju matlamat dalam mencapai keamanan dan keharmonian negara. Untuk itu, MCPF sentiasa bekerjasama dengan pelbagai pihak berkuasa bagi memastikan objektif ini dapat direalisasikan.

Makluman

- 2.8 Walaupun dalam keadaan pandemik Covid-19, MCPF terus melaksanakan program-program pencegahan jenayah dengan menggunakan pelbagai kaedah dan norma baharu di dalam semua program dan aktiviti di peringkat negeri dan daerah. Antaranya dengan meningkatkan dan memaksimumkan penggunaan teknologi digital sebagai platform untuk memberi pendedahan berhubung pencegahan jenayah kepada masyarakat melalui aplikasi seperti Facebook, Whatsapp, Youtube dan sebagainya.

Makluman

- 2.9 YB Pengerusi merakamkan ucapan penghargaan kepada ahli-ahli MCPF di semua peringkat yang telah mengambil inisiatif untuk menghulurkan pelbagai bantuan yang amat diperlukan oleh petugas-petugas barisan hadapan (*frontliners*), selain kepada ahli masyarakat lain yang memerlukan bantuan semasa penularan virus Covid-19.

Makluman

- 2.10 YB Pengerusi mengucapkan tahniah kepada semua pihak, terutamanya PDRM di atas penurunan indeks jenayah negara yang ketara sepanjang beberapa tahun yang lepas.

Makluman

- 2.11 Jenayah siber pula meningkat dan merunsingkan semua pihak di mana kebanyakan mangsa jenayah tersebut adalah terdiri daripada ahli perniagaan, kakitangan kerajaan dan swasta, pelajar dan mereka yang tiada pekerjaan.

Makluman

- 2.12 YB Pengerusi menambah, kes jenayah siber ini sangat berkait rapat dengan situasi semasa dalam negara apabila ramai di antara kita menjadikan internet sebagai platform untuk melakukan tugas bekerja dari rumah, pembelajaran secara maya, membeli belah dan melakukan transaksi perbankan. Walaupun pihak PDRM dan agensi-agensi lain mengambil pelbagai inisiatif untuk mengatasi jenayah siber ini, namun ia terus berleluasa dan semakin ramai di kalangan anggota masyarakat menjadi mangsa dan kehilangan jutaan ringgit saban tahun.

Makluman

- 2.13 YB Pengerusi mencadangkan agar MCPF sama ada di peringkat Pusat mahupun di peringkat negeri mahupun daerah untuk memberi perhatian serius kepada jenayah siber ini. Program-program berbentuk pendidikan dan kesedaran perlu dilaksanakan secara berterusan melibatkan semua lapisan masyarakat.

Tindakan: MCPF Pusat, Negeri dan Daerah

- 2.14 Masalah penyalahgunaan dadah masih menjadi musuh no. 1 negara dari tahun 80-an sehinggalah sekarang. Walaupun pelbagai pendekatan diambil oleh agensi penguatkuasa, namun dadah masih bermaharajalela di negara ini.

Makluman

- 2.15 Penyeludupan dadah dari negara jiran masih berlaku walaupun sempadan negara dikawal rapi setiap masa. Makmal-makmal memproses dadah juga terus beroperasi dan sering dibongkarkan oleh pihak berkuasa dari masa ke semasa.

Makluman

- 2.16 YB Pengerusi menyeru agar memperbanyakkan program-program berbentuk kesedaran berkaitan dadah khususnya kepada golongan pelajar dan belia. Kerjasama di antara agensi-agensi lain juga perlu dipertingkatkan lagi.

Makluman

- 2.17 YB Pengerusi menerangkan bahawa aktiviti dan program MCPF perlu inovatif dan berimpak tinggi dan tidak hanya bergantung kepada aktiviti Polis Diraja Malaysia (PDRM) semata-mata. Malah perlu lebih dilihat sebagai aktiviti kemasyarakatan dengan kolaborasi pelbagai badan bukan kerajaan, pihak swasta dan agensi-agensi bukan penguatkuasaan yang lain.

Makluman

- 2.18 YB Pengerusi berharap MCPF terus berusaha membantu pihak penguatkuasa dalam usaha membanteras jenayah di negara ini. Ahli-ahli MCPF harus mengeratkan hubungan sesama sendiri, mengutamakan integriti dan memberikan komitmen yang tinggi serta padu di dalam menjayakan visi dan misi MCPF.

- 2.19 Akhir kata, YAB Pengerusi berharap mesyuarat pada hari ini dapat berjalan dengan lancar dan jayanya.

- 4.1 Setiausaha Kehormat memaklumkan bahawa MCPF dengan kerjasama agensi-agensi kerajaan yang lain telah merangka dan menganjurkan pelbagai program berbentuk kesedaran seperti seminar, ceramah dan taklimat berkaitan jenayah siber melalui atas talian (*online/google meet*). Selain itu, MCPF melalui aplikasi Facebook dan Whatsapp juga mengedarkan tips-tips pencegahan jenayah siber kepada orang ramai.

Cadangan Mengurangkan Yuran Tahunan Keahlian

- 4.2 Setiausaha Kehormat memaklumkan kenaikan yuran keahlian MCPF telah dipersetujui oleh ahli-ahli MCPF dalam Mesyuarat AGM MCPF yang diadakan pada tahun 2017. Sehubungan itu, Jawatankuasa Keahlian MCPF berpendapat yuran ini adalah amat berpatutan dan tidak perlu dikurangkan lagi.

Calon-Calon Yang Bertanding Dalam Pemilihan MCPF Perlu Menjadi Ahli MCPF Sekurang-Kurangnya Satu Tahun

- 4.3 Setiausaha Kehormat memaklumkan cadangan ini akan dibincangkan dalam Agenda Mesyuarat Agung Tahunan kali ini sebagai salah satu usul yang dikemukakan oleh ahli MCPF.

- 4.4 Setiausaha Kehormat memaklumkan Jawatankuasa Pengurusan MCPF telah bersetuju dengan cadangan untuk MCPF mempunyai bendera dan lagu MCPF tersendiri dan sedang dalam proses merangka lirik lagu dan bendera MCPF.

Melantik Semua Pengetua / Guru Besar Sekolah Serta Pengarah Institut Pendidikan Guru di Malaysia Sebagai Ahli Bersekutu MCPF

- 4.5 Setiausaha Kehormat memaklumkan bahawa Ketua Setiausaha Kementerian Pendidikan Tinggi dan Ketua Pengarah Kementerian Pendidikan Malaysia (KPM) adalah ahli EXCO Ex-officio MCPF. Sehubungan itu, KPM dan MCPF berpendapat tiada keperluan untuk melantik Pengetua, Guru Besar dan Pengarah Institut Pendidikan Guru sebagai Ahli Bersekutu MCPF.

Makluman

Mengadakan *Retreat* Di Peringkat Negeri Dan Daerah Untuk Memberi Pendedahan Tentang Peranan MCPF Kepada Ahli-Ahlinya

- 4.6 Setiausaha Kehormat menjelaskan Jawatankuasa Latihan dan Pembangunan MCPF telah merancang untuk mengadakan *retreat* kepada ahli-ahli MCPF mengikut zon bermula pada bulan Jun 2022.

5. MEMBENTANGKAN DAN MELULUSKAN LAPORAN TAHUNAN 2020

- 5.1 Setiausaha Kehormat telah membentangkan buku Laporan Tahunan 2020 sepertimana yang telah diedarkan kepada semua ahli mesyuarat.
- 5.2 Laporan Tahunan 2020 telah dicadangkan sah oleh YBhg. Datuk Mak Foo Wei (No. Ahli: 102057) dan telah disokong oleh Encik Mah Yoke Keong (No. Ahli: 102350).

6. MEMBENTANGKAN DAN MELULUSKAN LAPORAN PENYATA KEWANGAN TAHUN BERAKHIR 31 DISEMBER 2020

- 6.1 YBhg. Tan Sri Datuk Eddy Chen selaku Bendahari MCPF telah membentangkan Laporan Penyata Kewangan Tahun Berakhir 31 Disember 2020. Laporan telah diaudit oleh Juruaudit Bertauliah iaitu Deloitte PLT.

7.2.1 Mencadangkan:

- i) Mengekalkan barisan Exco sedia ada untuk satu (1) penggal berikutnya.
- ii) Tempoh penggal Exco dilanjutkan dari dua (2) tahun ke tiga (3) tahun.

Jika usul untuk memanjangkan tempoh penggal ahli Exco dari dua (2) tahun ke tiga (3) tahun diluluskan, maka Artikel 8(e) Perlembagaan MCPF akan dipinda dan akan berkuatkuasa bagi penggal akan datang. YB Pengerusi memaklumkan bahawa kuasa untuk menangguhkan pemilihan Exco adalah terletak dalam bidang kuasa Jabatan Pendaftaran Pertubuhan Malaysia (JPPM). Tambahan pula, penangguhan pemilihan Exco tidak termaktub dalam Perlembagaan MCPF. YB Pengerusi menyatakan sokongan terhadap pelanjutan tempoh penggal ahli Exco menjadi tiga (3) tahun berkuatkuasa pada penggal yang akan datang.

**NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 DECEMBER 2021**

1. GENERAL INFORMATION

The principal objectives of the Foundation are to contribute to the enhancement of effective measures for crime prevention and the treatment of offenders, and to promote public awareness of and participation in crime prevention efforts. The Foundation is a non-profit organisation.

The total number of employees of the Foundation as at 31 December 2021 was 6 (2020: 6).

The registered office of the Foundation is B-3A-13 Blok B Level 4 Unit 13, Megan Avenue II, Jalan Yap Kwan Seng, 50450 Kuala Lumpur.

The financial statements were approved and authorised for issue in accordance with a resolution of the Executive Council dated 28 February 2023.

2. BASIS OF PREPARATION OF THE FINANCIAL STATEMENTS

The financial statements of the Foundation have been prepared in accordance with Malaysian Private Entities Reporting Standard ("MPERS") issued by the Malaysian Accounting Standards Board ("MASB").

3. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Foundation have been prepared under the historical cost convention.

Income Recognition

Income is recognised to the extent that it is probable that the economic benefits will flow to the Foundation and the revenue can be reliably measured. Income is measured at the fair value of consideration received or receivable.

(i) Income from donation and entrance fee

Income from donation and entrance fee is recognised on a receipt basis.

(ii) Annual subscription fee

Annual subscription fee income is recognised on an accrual basis.

(iii) **Interest income**

Interest income is recognised on an accrual basis.

(iv) **Dividend income**

Dividend income is recognised when the right to receive payment is established.

Tax Expense

The Foundation is exempted from taxation under the Paragraph 13, Schedule 6 of the Income Tax (Amendment) Act, 1967.

Foreign Currency

Functional currency is the currency of the primary economic environment in which the entity operates.

The financial statements are presented in Ringgit Malaysia ("RM"), which is the Foundation's functional and presentation currency. The Foundation determines its functional currency as RM and measures its results and financial position in that functional currency.

Transactions denominated in foreign currencies are translated and recorded at the rates of exchange prevailing at the respective dates of transaction. At the end of each reporting year, monetary items denominated in foreign currencies are retranslated at the rates prevailing at the end of the year. Non-monetary items that are measured at their historical cost amounts continue to be translated at their respective historical rates and are not retranslated.

All exchange differences arising on settled transactions and on unsettled monetary items are recognised in profit or loss in the year.

Employee Benefits

(i) **Short-term employee benefits**

Wages, salaries, paid annual leave and sick leave, bonuses and non-monetary benefits are recognised as an expense in the year in which the associated services are rendered by the employees of the Foundation.

(ii) **Defined contribution plans**

The Foundation's contributions to the Employees Provident Fund are recognised in the statement of income and expenditure in the financial year to which they relate. Once the contributions have been paid, the Foundation has no further payment obligations and other staff benefits.

Impairment of Assets

The carrying amounts of plant and equipment are reviewed at the end of the reporting year to determine whether there is any indication of impairment. If such an indication exists, the assets' recoverable amounts are estimated. An impairment loss is recognised whenever the carrying amount of an asset or its cash-generating unit exceeds its recoverable amount. All impairment losses are charged to the profit or loss.

The recoverable amount of an asset is the higher of its fair value less costs to sell and its value-in-use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

An impairment loss is only reversed to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised. All reversals are recognised in the statement of comprehensive income.

Plant and Equipment

Plant and equipment are stated at cost less accumulated depreciation and any accumulated impairment losses.

The straight line method is used to write off the cost of the assets over the term of their estimate useful lives at the following principal annual rates:

Building	2%
Computer	25%
Office furniture, fittings and renovation	25%
Motor vehicles	25%
Office equipment	25%

Gain or loss arising from the disposal of an asset is determined as the difference between the net disposal proceeds and the carrying amount of the asset, and is recognised in the statement of comprehensive income.

Provisions

Provisions are made when the Foundation has a present legal or constructive obligation as a result of past events, when it is probable that an outflow of resources will be required to settle the obligation, and when a reliable estimate of the amount can be made.

Provisions are reviewed at the end of each reporting year and adjusted to reflect the current best estimate. Where the effect of time value of money is material, the amount of provision is the present value of the expenditure expected to be required to settle the obligation.

Financial Instruments

(a) Initial Recognition and Measurement

The Foundation recognises a financial asset or a financial liability in the statement of financial position when, and only when, the Foundation becomes a party to the contractual provisions of the instrument.

On initial recognition, all financial assets and financial liabilities are measured at fair value, which is generally the transaction price, plus transaction costs if the financial asset or financial liability is not measured at fair value through profit or loss. For instruments measured at fair value through profit or loss, transaction costs are expensed to profit or loss when incurred.

(b) Derecognition of Financial Instruments

For derecognition purposes, the Foundation first determines whether a financial asset or a financial liability should be derecognised in its entirety as a single item or derecognised part-by-part of a single item or of a group of similar items.

A financial asset, whether as a single item or as a part, is derecognised when, and only when, the contractual rights to receive the cash flows from the financial asset expire, or when the Foundation transfers the contractual rights to receive cash flows of the financial asset, including circumstances when the Foundation acts only as a collecting agent of the transferee, and retains no significant risks and rewards of ownership of the financial asset or no continuing involvement in the control of the financial asset transferred.

A financial liability is derecognised when, and only when, it is legally extinguished, which is either when the obligation specified in the contract is discharged or cancelled or expires. A substantial modification of the terms of an existing financial liability is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability. For this purpose, the Foundation considers a modification as substantial if the present value of the revised cash flows of the modified terms discounted at the original effective interest rate differs by 10% or more when compared with the carrying amount of the original liability.

(c) Subsequent Measurement of Financial Assets

After initial recognition measurement, the Foundation measures all financial assets at amortised cost using the effective interest method.

All financial assets are subject to review for impairment in accordance with impairment and uncollectibility of financial assets.

(d) Subsequent Measurement of Financial Liabilities

After initial recognition, the Foundation measures all financial liabilities at amortised cost using the effective interest method.

(e) **Recognition of Gains and Losses**

For financial assets and liabilities carried at amortised cost, a gain or loss is recognised in the statement of comprehensive income only when the financial asset or liability is derecognised or impaired, and through the amortisation process of the instrument.

(f) **Impairment and Uncollectibility of Financial Assets**

The Foundation applies the incurred loss model to recognise impairment losses of financial assets. At the end of each reporting period, the Foundation examines whether there is any objective evidence that a financial asset or a group of financial assets is impaired. Evidences of trigger loss events include:

- (i) significant difficulty of the issuer or obligor;
- (ii) a breach of contract, such as a default or delinquency in interest or principal payment;
- (iii) granting exceptional concession to a customer;
- (iv) it is probable that a customer will enter bankruptcy or other financial reorganisation;
- (v) the disappearance of an active market for that financial asset because of financial difficulties; or
- (vi) any observable market data indicating that there may be a measurable decrease in the estimated future cash flows from a group of financial assets.

For a non-current loan and receivable carried at amortised cost, the revised estimated cash flows are discounted at the original effective interest rate. Any impairment loss is recognised in the statement of comprehensive income and a corresponding amount is recorded in a loss allowance account. Any subsequent reversal of impairment loss of the financial asset is reversed in profit or loss with a corresponding adjustment to the allowance account, subject to the limit that the reversal should not result in the revised carrying amount of the financial asset exceeding the amount that would have been determined had no impairment loss been recognised previously.

For short-term trade and other receivables, where the effect of discounting is immaterial, impairment loss is tested for each individually significant receivable wherever there is any indication of impairment. Individually significant receivables for which no impairment loss is recognised are grouped together with all other receivables by classes based on credit risk characteristics and aged according to the past due periods. A collective allowance is estimated for a class group based on the experiences of loss ratio in each class, taking into consideration current market conditions.

Operating Lease

A lease is classified as an operating lease if it does not transfer substantially all the risks and rewards incidental to ownership.

The lease payments under an operating lease are recognised as an expense on the straight-line basis over the lease term unless another systematic basis is more representative of the time pattern of the user's benefit.

Statement of Cash Flows

The Foundation adopts the indirect method in the preparation of the statement of cash flows. Cash equivalents are short-term, highly liquid investments with maturities of three months or less from the date of acquisition and are readily convertible to cash with insignificant risk of changes in value.

4. INCOME TAX EXPENSE

No provision for estimated current tax payable has been made as the Foundation is exempted from taxation under the Paragraph 13, Schedule 6 of the Income Tax (Amendment) Act, 1967.

**NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 DECEMBER 2022**

1. GENERAL INFORMATION

The principal objectives of the Foundation are to contribute to the enhancement of effective measures for crime prevention and the treatment of offenders, and to promote public awareness of and participation in crime prevention efforts. The Foundation is a non-profit organisation.

The total number of employees of the Foundation as at 31 December 2022 was 9 (2021: 6).

The registered office of the Foundation is B-3A-13 Blok B Level 4 Unit 13, Megan Avenue II, Jalan Yap Kwan Seng, 50450 Kuala Lumpur.

The financial statements were approved and authorised for issue in accordance with a resolution of the Executive Council dated 3 March 2023.

2. BASIS OF PREPARATION OF THE FINANCIAL STATEMENTS

The financial statements of the Foundation have been prepared in accordance with Malaysian Private Entities Reporting Standard (“MPERS”) issued by the Malaysian Accounting Standards Board (“MASB”).

3. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Foundation have been prepared under the historical cost convention.

Income Recognition

Income is recognised to the extent that it is probable that the economic benefits will flow to the Foundation and the revenue can be reliably measured. Income is measured at the fair value of consideration received or receivable.

(i) Income from donation and entrance fee

Income from donation and entrance fee is recognised on a receipt basis.

(ii) Annual subscription fee

Annual subscription fee income is recognised on an accrual basis.

(iii) **Interest income**

Interest income is recognised on an accrual basis.

(iv) **Dividend income**

Dividend income is recognised when the right to receive payment is established.

Tax Expense

The Foundation is exempted from taxation under the Paragraph 13, Schedule 6 of the Income Tax (Amendment) Act, 1967.

Foreign Currency

Functional currency is the currency of the primary economic environment in which the entity operates.

The financial statements are presented in Ringgit Malaysia ("RM"), which is the Foundation's functional and presentation currency. The Foundation determines its functional currency as RM and measures its results and financial position in that functional currency.

Transactions denominated in foreign currencies are translated and recorded at the rates of exchange prevailing at the respective dates of transaction. At the end of each reporting year, monetary items denominated in foreign currencies are retranslated at the rates prevailing at the end of the year. Non-monetary items that are measured at their historical cost amounts continue to be translated at their respective historical rates and are not retranslated.

All exchange differences arising on settled transactions and on unsettled monetary items are recognised in profit or loss in the year.

Employee Benefits

(i) **Short-term employee benefits**

Wages, salaries, paid annual leave and sick leave, bonuses and non-monetary benefits are recognised as an expense in the year in which the associated services are rendered by the employees of the Foundation.

(ii) **Defined contribution plans**

The Foundation's contributions to the Employees Provident Fund are recognised in the statement of income and expenditure in the financial year to which they relate. Once the contributions have been paid, the Foundation has no further payment obligations and other staff benefits.

Impairment of Assets

The carrying amounts of plant and equipment are reviewed at the end of the reporting year to determine whether there is any indication of impairment. If such an indication exists, the assets' recoverable amounts are estimated. An impairment loss is recognised whenever the carrying amount of an asset or its cash-generating unit exceeds its recoverable amount. All impairment losses are charged to the profit or loss.

The recoverable amount of an asset is the higher of its fair value less costs to sell and its value-in-use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

An impairment loss is only reversed to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised. All reversals are recognised in the statement of comprehensive income.

Plant and Equipment

Plant and equipment are stated at cost less accumulated depreciation and any accumulated impairment losses.

The straight line method is used to write off the cost of the assets over the term of their estimate useful lives at the following principal annual rates:

Building	2%
Computer	25%
Office furniture, fittings and renovation	25%
Motor vehicles	25%
Office equipment	25%

Gain or loss arising from the disposal of an asset is determined as the difference between the net disposal proceeds and the carrying amount of the asset, and is recognised in the statement of comprehensive income.

Provisions

Provisions are made when the Foundation has a present legal or constructive obligation as a result of past events, when it is probable that an outflow of resources will be required to settle the obligation, and when a reliable estimate of the amount can be made.

Provisions are reviewed at the end of each reporting year and adjusted to reflect the current best estimate. Where the effect of time value of money is material, the amount of provision is the present value of the expenditure expected to be required to settle the obligation.

Financial Instruments

(a) Initial Recognition and Measurement

The Foundation recognises a financial asset or a financial liability in the statement of financial position when, and only when, the Foundation becomes a party to the contractual provisions of the instrument.

On initial recognition, all financial assets and financial liabilities are measured at fair value, which is generally the transaction price, plus transaction costs if the financial asset or financial liability is not measured at fair value through profit or loss. For instruments measured at fair value through profit or loss, transaction costs are expensed to profit or loss when incurred.

(b) Derecognition of Financial Instruments

For derecognition purposes, the Foundation first determines whether a financial asset or a financial liability should be derecognised in its entirety as a single item or derecognised part-by-part of a single item or of a group of similar items.

A financial asset, whether as a single item or as a part, is derecognised when, and only when, the contractual rights to receive the cash flows from the financial asset expire, or when the Foundation transfers the contractual rights to receive cash flows of the financial asset, including circumstances when the Foundation acts only as a collecting agent of the transferee, and retains no significant risks and rewards of ownership of the financial asset or no continuing involvement in the control of the financial asset transferred.

A financial liability is derecognised when, and only when, it is legally extinguished, which is either when the obligation specified in the contract is discharged or cancelled or expires. A substantial modification of the terms of an existing financial liability is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability. For this purpose, the Foundation considers a modification as substantial if the present value of the revised cash flows of the modified terms discounted at the original effective interest rate differs by 10% or more when compared with the carrying amount of the original liability.

(c) Subsequent Measurement of Financial Assets

After initial recognition measurement, the Foundation measures all financial assets at amortised cost using the effective interest method.

All financial assets are subject to review for impairment in accordance with impairment and uncollectibility of financial assets.

(d) Subsequent Measurement of Financial Liabilities

After initial recognition, the Foundation measures all financial liabilities at amortised cost using the effective interest method.

(e) **Recognition of Gains and Losses**

For financial assets and liabilities carried at amortised cost, a gain or loss is recognised in the statement of comprehensive income only when the financial asset or liability is derecognised or impaired, and through the amortisation process of the instrument.

(f) **Impairment and Uncollectibility of Financial Assets**

The Foundation applies the incurred loss model to recognise impairment losses of financial assets. At the end of each reporting period, the Foundation examines whether there is any objective evidence that a financial asset or a group of financial assets is impaired. Evidences of trigger loss events include:

- (i) significant difficulty of the issuer or obligor;
- (ii) a breach of contract, such as a default or delinquency in interest or principal payment;
- (iii) granting exceptional concession to a customer;
- (iv) it is probable that a customer will enter bankruptcy or other financial reorganisation;
- (v) the disappearance of an active market for that financial asset because of financial difficulties; or
- (vi) any observable market data indicating that there may be a measurable decrease in the estimated future cash flows from a group of financial assets.

For a non-current loan and receivable carried at amortised cost, the revised estimated cash flows are discounted at the original effective interest rate. Any impairment loss is recognised in the statement of comprehensive income and a corresponding amount is recorded in a loss allowance account. Any subsequent reversal of impairment loss of the financial asset is reversed in profit or loss with a corresponding adjustment to the allowance account, subject to the limit that the reversal should not result in the revised carrying amount of the financial asset exceeding the amount that would have been determined had no impairment loss been recognised previously.

For short-term trade and other receivables, where the effect of discounting is immaterial, impairment loss is tested for each individually significant receivable wherever there is any indication of impairment. Individually significant receivables for which no impairment loss is recognised are grouped together with all other receivables by classes based on credit risk characteristics and aged according to the past due periods. A collective allowance is estimated for a class group based on the experiences of loss ratio in each class, taking into consideration current market conditions.

Operating Lease

A lease is classified as an operating lease if it does not transfer substantially all the risks and rewards incidental to ownership.

The lease payments under an operating lease are recognised as an expense on the straight-line basis over the lease term unless another systematic basis is more representative of the time pattern of the user's benefit.

Statement of Cash Flows

The Foundation adopts the indirect method in the preparation of the statement of cash flows. Cash equivalents are short-term, highly liquid investments with maturities of three months or less from the date of acquisition and are readily convertible to cash with insignificant risk of changes in value.

4. INCOME TAX EXPENSE

No provision for estimated current tax payable has been made as the Foundation is exempted from taxation under the Paragraph 13, Schedule 6 of the Income Tax (Amendment) Act, 1967.
